- (1) The sales reported in this Form 4 were effected pursuant to a Rule 10b5-1 trading plan.
- (2) Represents the sale of 50,000 shares in 30 separate transactions, ranging from \$6.87 to \$7.02 per share, resulting in a weighted average sale price per share of \$6.95.
- (3) Consists of 75,000 unvested Restricted Stock Units, which will vest in four annual installments of 10%, 20%, 30% and 40%, respectively, starting on June 3, 2012.
