On September 27, 2011, Cheniere Energy Partners, L.P. (the "Partnership") provided notice to the Reporting Person of the exercise of the Partnership's option to require the Reporting Person to purchase 450,000 common units representing limited partner interests in the Partnership pursuant to a Purchase Agreement, dated September 14, 2011, by and among the Reporting Person, the Partnership, Cheniere Energy Partners GP, LLC and Cheniere Energy Investments, LLC. The closing of the sale of the 450,000 common units to the Reporting Person occurred on September 30, 2011. The Reporting Person is a wholly owned subsidiary of Cheniere LNG Holdings, LLC, Cheniere LNG Terminals, Inc., Cheniere LNG, Inc. and Cheniere Energy, Inc., and as such, each of these entities is an indirect beneficial owner of the reported securities.
