(1) Shares held following the reported transactions include 57,700 restricted stock units, which are subject to forfeiture until they vest.

(2) In accordance with Rule 16b-3, shares reported as disposed of were withheld by the Company and not issued to the reporting person in order to cover withholding taxes incident to the vesting of restricted stock units.

(3) Award represents a total of 28,100 restricted stock units granted under the terms of the Issuer's 2005 Stock Plan. Each unit represents a contingent right to receive one share of the Issuer's Class A Common Stock upon vesting.
