On July 9, 2013, the Reporting Person was granted 9,000 restricted stock units (the "RSUs") under the Amarin Corporation plc 2011 Stock Incentive Plan. Each RSU represents a contingent right to receive one Ordinary Share or cash in lieu thereof at the Issuer's discretion, with settlement to be made on a deferred basis, specifically upon the non-employee director's separation of service with the Company. The RSUs vest in equal annual installments over a three-year period, with each installment vesting upon the earlier of (i) the anniversary of the grant date of July 9, 2013 or (ii) the Issuer's next annual meeting of stockholders.

(1) The RSUs vest in equal annual installments over a three-year period, with each installment vesting upon the earlier of (i) the anniversary of the grant date of July 9, 2013 or (ii) the Issuer's next annual meeting of stockholders.

(2) The Ordinary Shares may be represented by American Depositary Shares, each of which currently represents one Ordinary Share.

(3) This option vests in full upon the earlier of (i) the one-year anniversary of the grant date of July 9, 2013 or (ii) the Issuer's next annual meeting of stockholders.
