 - (1) 20,000 stock options with an exercise price of \$3.95 were granted on July 30, 2004.  - (2) 12,652 restricted stock units were granted on August 12, 2013 (the "2013 RSUs"). Each 2013 RSU represents a contingent right to receive one share of common stock. The 2013 RSUs vest in two equal installments on February 12, 2014 and August 12, 2014.
