- (1) Bain Capital Investors, LLC ("BCI") is the sole general partner of Bain Capital Partners IX, L.P. ("BCP IX"), which is the sole general partner of Bain Capital Fund IX, L.P. ("Fund IX LP"), which is the sole member of Bain Capital Fund IX, LLC ("Fund IX"). On May 30, 2014, Fund IX sold 859,716 shares of Common Stock. Following such sale, Fund IX held 19,498,201 shares of Common Stock.
- (2) BCI is also the administrative member of Bain Capital Integral Investors, LLC ("Integral"). On May 30, 2014, Integral sold 918,526 shares of Common Stock. Following such sale, Integral held 20,831,982 shares of Common Stock.
- (3) BCI is also the administrative member of BCIP TCX, LLC ("BCIP TCX"). On May 30, 2014, BCIP TCX sold 21,332 shares of Common Stock. Following such sale, BCIP TCX held 483,796 shares of Common Stock.
- (4) BCI is also the managing partner of BCIP Associates-G ("BCIP G" and together with Fund IX, Integral and BCIP TCX, the "Bain Entities"). On May 30, 2014, BCIP G sold 426 shares of Common Stock. Following such sale, BCIP G held 9,660 shares of Common Stock.

(5) Tricia Patrick is a Principal of BCI. By virtue of the relationships described in these footnotes, Ms. Patrick may be deemed to share voting and dispositive power with respect to the shares of Common Stock held by Bain Entities. Ms. Patrick disclaims beneficial ownership of such securities except to the extent of his pecuniary interest therein.
