- (1) These Phantom Stock Units were acquired under the IR Executive Deferred Compensation Plan II (the "EDCP II"), and, subject to the vesting provisions of the EDCP II, are convertible on a one-for-one basis.
- (2) The Reporting Person effected an intra-plan transfer of funds held in the Company stock fund to another investment option under the EDCP II. The transaction was a discretionary transaction exempt under 16b-3(f). The transaction resulted in a disposition of 9009.82 Phantom Stock Units at \$51.69 per share. The amount of units disposed of was originally reported as 1928.46 units due to an administrative error.
- (3) Beneficial ownership of Phantom Stock Units was overstated in the original filing as a result of the administrative error.
