As of December 31, 2006, I was the beneficial owner of 3,535,792 shares of Class A Common Stock for the purpose of Section 13(g) of the Securities Exchange Act of 1934 by virtue of Rule 13d-3. This ownership consisted of (i) 3,455,263 shares of Class B Common Stock (which are convertible on a one-for-one basis into shares of Class A Common Stock) owned directly by me; (ii) 15,000 shares of Class A Common Stock held of record by my wife (as to which I disclaim beneficial ownership); (iii) 42,000 shares of Class A or B Common Stock issuable upon the exercise of stock options which were exercisable on December 31, 2006 or within 60 days thereafter; and (iv) 23,529 shares of Class B Common Stock held by me through the Company's Savings and Investment Plan.

If all of the Class B Common Stock I beneficially owned as of December 31, 2006 and all of the shares issuable upon the exercise of stock options that I beneficially owned of as December 31, 2006 (which stock options were exercisable on December 31, 2006 or within 60 days thereafter) were converted into Class A Common Stock, then as of December 31, 2006, I beneficially owned 6.2% of the outstanding Class A Common Stock, computed in accordance with Rule 13d-3.
