Item 1.01. Entry into a Material Definitive Agreement.

On November 24, 2004, Riverstone Networks, Inc. ( Riverstone or the Registrant ), along with certain current and former directors and officers of Registrant, entered into an agreement with St. Paul Mercury Insurance Company ( St. Paul ). Under the terms of the settlement, St. Paul agreed to pay Registrant \$7.6 million in cash, constituting a majority of the proceeds of the \$10 million directors and officers liability insurance policy issued by St. Paul covering Registrant and its directors and officers. The payments are to be used to pay, in part, the \$20.25 million class action and derivative litigation settlements announced by Registrant earlier this year. In exchange for the payment by St. Paul, the parties agreed to mutual releases of all claims with respect to the St. Paul insurance policy.

Riverstone received payment of the \$7.6 million on November 24. The class action and derivative litigation settlement payments will be made upon preliminary court approval of the settlements.
