#### DEREGISTRATION OF UNSOLD SECURITIES

This Post-Effective Amendment No. 1 relates to the Registration Statement on Form S-8 (File No. 333-92132) (the Registration Statement ) of SLM Corporation (formerly USA Education, Inc. and formerly SLM Holding Corporation) (the Company ), a Delaware corporation, which was filed with the Securities and Exchange Commission and became effective on July 9, 2002.
