**Plan for SOC Infrastructure Fund Establishment**

Kookmin Bank has a plan to establish a SOC Infrastructure Fund which amounts to KRW 500 billion ~ KRW 1 trillion. This fund will be invested in SOC projects such as bridges, tunnels, highways, and harbors of large scale with sufficient future cash flow.

The plan for SOC Infrastructure Fund is subject to change with respect to the internal decision-making process.
