Attached is an English translation of the summary of the letter dated June, 22 filed by the Company with the *Bolsa de Comercio de Buenos Aires* and the *Comisión Nacional de Valores*.

By letter dated June 22, 2006, the Company reported that three holders of the Company's Convertible Notes exercised their conversion right. Hence, the financial indebtedness of the Company shall be reduced in US\$ 1,481,636 while a capital increase of 2,917,753 common shares of face value pesos 1 each has been completed. The conversion was performed according to the terms and conditions established in the prospectus at the conversion rate of 1.96928 shares, face value pesos 1 per Convertible Note of face value US\$ 1.

As a result of the above referred conversion, the number of outstanding shares of the Company is increased from 188,889,040 to 191,806,793. Therefore, the amount of registered Convertible Notes is US\$ 27,734,272.
