On October 16, 2006, Newport Corporation (the Registrant) entered into a definitive agreement to acquire the Laser Products business of Picarro, Inc. The Laser Products business designs and manufactures solid-state lasers targeted primarily at the life and health sciences and process control markets. The transaction is subject to customary closing conditions and is expected to close in early November 2006.
