Item 4. Ownership.

(a) Amount beneficially owned:

QVT Financial LP (QVT Financial) is the investment manager for QVT Fund LP (the Fund), which beneficially owns 1,094,119 shares of Common Stock. QVT Financial is the investment manager for Quintessence Fund L.P. (Quintessence), which beneficially owns 111,072 shares of Common Stock. QVT Financial has the power to direct the vote and disposition of the Common Stock held by each of the Fund and Quintessence.

Accordingly, QVT Financial may be deemed to be the beneficial owner of an aggregate amount of 1,205,191 shares of Common Stock, consisting of the shares owned by the Fund and Quintessence.

QVT Financial GP LLC, as General Partner of QVT Financial, may be deemed to beneficially own the same number of shares of Common Stock reported by QVT Financial. QVT Associates GP LLC, as General Partner of the Fund and Quintessence, may be deemed to beneficially own the aggregate number of shares of Common Stock owned by the Fund and Quintessence, and accordingly, QVT Associates GP LLC may be deemed to be the beneficial owner of an aggregate amount of 1,205,191 shares of Common Stock.

Each of QVT Financial and QVT Financial GP LLC disclaim beneficial ownership of the shares of Common Stock beneficially owned by the Fund and Quintessence. QVT Associates GP LLC disclaims beneficial ownership of all shares of Common Stock owned by the Fund and Quintessence, except to the extent of its pecuniary interest therein.

The Fund and Quintessence also own warrants to purchase additional shares of Common Stock that are not exercisable until the later of the Issuer 's completion of a business combination and June 25, 2009. As of the date of this filing, there has been no report of the completion of a business combination.

The percentage disclosed in Item 11 of the Cover Pages for each reporting person is calculated based upon 31,625,000 shares of Common Stock outstanding, which is the total number of shares issued and outstanding as reported in the Issuer 's Proxy Statement on Form 6-K, filed with the Securities and Exchange Commission on October 30, 2009.
