On May 4, 2011, Alpha Beta Netherlands Holding N.V., Beursplein 5, 1012 JW Amsterdam, the Netherlands (the **Bidder**) published the exchange offer document regarding its voluntary public takeover offer (the **exchange offer**) to the shareholders of Deutsche Börse Aktiengesellschaft, Frankfurt am Main, Germany, registered in the commercial register (*Handelsregister*) of the Local Court (*Amtsgericht*) of Frankfurt am Main under HRB 32232 with its business address at Mergenthaler Allee 61, 65760 Eschborn, Germany, to the extent these are not excluded from the exchange offer as set forth in the exchange offer document, to acquire all registered no-par-value shares of Deutsche Börse (ISIN DE0005810055) (**Deutsche Börse shares**) for consideration of one Deutsche Börse share for one new ordinary share in the Bidder (ISIN NL0009766997). The exchange offer and the agreements which come into existence as a result of accepting the exchange offer are subject to various conditions (the **completion conditions**). The Bidder has waived certain of the completion conditions. The offer acceptance period remains unchanged by this amendment to the exchange offer and still expires midnight, at the end of July 13, 2011 (Central European Daylight Savings Time).

( Holding ), a newly formed holding company, has filed, and the SEC has declared effective on May 3, 2011, a Registration Statement on Form F-4 with the U.S. Securities and Exchange Commission ( SEC ) that includes (1) a proxy statement of NYSE Euronext that will also constitute a prospectus for Holding and (2) an offering prospectus of Holding to be used in connection with Holding s offer to acquire Deutsche Boerse AG shares held by U.S. holders. Holding has also filed an offer document with the German Federal Financial Supervisory Authority (Bundesanstalt fuer Finanzdienstleistungsaufsicht) ( BaFin ), which was approved by the BaFin for publication pursuant to the German Takeover Act (Wertpapiererwerbs-und Übernahmegesetz), and was published on May 4, 2011.
