On January 18, 2013, Career Education Corporation (the <u>Company</u>) received notification that the Higher Learning Commission (<u>HLC</u>) acted to continue the accreditation of Colorado Technical University (<u>CTU</u>). The next reaffirmation of accreditation is scheduled for 2022-2023. CTU will have a comprehensive review in 2016-17 and was asked to provide two interim monitoring reports to HLC, which will be completed by July 2013.

CTU issued a press release regarding the reaffirmation of accreditation by HLC on January 29, 2013, a copy of which is attached as Exhibit 99.1, and the information contained therein is incorporated herein by reference.
