**Item 8.01 Other Events.**

On March 11, 2013, Virginia Electric and Power Company (the Company) entered into an underwriting agreement (the Underwriting Agreement) with Deutsche Bank Securities Inc., Morgan Stanley & Co. LLC and UBS Securities LLC, as Representatives for the underwriters named in the Underwriting Agreement, for the sale of \$500,000,000 aggregate principal amount of the Company's 2013 Series C 2.75% Senior Notes Due 2023. Such Senior Notes, which are designated the 2013 Series C 2.75% Senior Notes Due 2023, are Senior Debt Securities that were registered by the Company pursuant to a registration statement on Form S-3 under Rule 415 under the Securities Act of 1933, as amended, which registration statement became effective on December 28, 2011 (File No. 333-178772). A copy of the Underwriting Agreement, including exhibits thereto, is filed as Exhibit 1.1 to this Form 8-K.

The Twenty-Fifth Supplemental Indenture to the Company's June 1, 1998 Senior Indenture, as amended, pursuant to which the 2013 Series C 2.75% Senior Notes Due 2023 will be issued, is filed as Exhibit 4.3 to this Form 8-K.
