ITEM 1.01 Entry into a Material Definitive Agreement

On August 14, 2013, Universal Insurance Holdings, Inc. ( Company ) entered into a repurchase agreement with Norman M. Meier, the former Secretary and a former director of the Company ( Repurchase Agreement ). Pursuant to the Repurchase Agreement, the Company agreed to repurchase 241,933 shares of the Company s common stock owned by Mr. Meier ( Shares ). The repurchase of the Shares occurred today for a repurchase price of \$7.57 per share, representing a discount from the current market price of the Company s common stock. After the Company s repurchase of the Shares, Mr. Meier will no longer own any of the Company s outstanding common stock.

The preceding summary of the Repurchase Agreement does not purport to be complete and is qualified in its entirety by reference to the full text of the Repurchase Agreement, which is attached hereto as Exhibit 10.1 and is incorporated herein by reference.
