Aegon completes sale of equity stake in La Mondiale Participations

Aegon has completed the sale of its 35% share in La Mondiale Participations following the granting of approval by the French Competition Authority (Autorité de la Concurrence).

The agreement to sell Aegon s stake in La Mondiale Participations to La Mondiale for EUR 350 million was announced on November 24, 2014. Proceeds from the sale will be added to Aegon s excess capital buffer, and will increase the group s IGD solvency ratio by approximately 5 percentage points.
