EXPLANATORY NOTE

This Form 8-A/A is filed by VAALCO Energy, Inc. (the <u>Company</u>) to reflect the expiration of the preferred share purchase rights (the <u>Righ</u>ts) registered on the Form 8-A filed by the Company on September 28, 2015.

Item 1. Description of the Registrant s Securities to Be Registered.

On December 22, 2015, the Company entered into Amendment No. 1 (the <u>Amendment</u>) to the Rights Agreement (the <u>Rights Agreement</u>), dated as of September 26, 2015, between the Company and Computershare Trust Company, N.A., as Rights Agent. The Amendment accelerates the expiration of the Rights from 5:00 p.m., New York City time, on September 25, 2016 to 5:00 p.m., New York City time, on December 23, 2015, and has the effect of terminating the Rights Agreement on that date. At the time of the termination of the Rights Agreement, all of the Rights distributed to holders of the Company s common stock pursuant to the Rights Agreement will expire.
