This Amendment No. 3 to Schedule 13D (this <u>Amendment No.</u> 3) amends and supplements the statement on Schedule 13D (the <u>Original Schedule 13D</u>), filed on August 6, 2015 (the Original Schedule 13D, as amended and supplemented through the date of this Amendment No. 3, the <u>Schedule 13D</u>), by Pershing Square Capital Management, L.P., a Delaware limited partnership (<u>Pershing Square</u>); PS Management GP, LLC, a Delaware limited liability company (PS <u>Management</u>); and William A. Ackman, a citizen of the United States of America (together with Pershing Square and PS Management, the <u>Reporting Persons</u>), relating to the Class A common stock, no par value (the <u>Common Stock</u>), of Mondelez International, Inc., a Virginia corporation (the <u>Issuer</u>). Capitalized terms used but not defined in this amendment shall have the meanings set forth in the Schedule 13D.

Except as specifically amended by this Amendment No. 3, the Schedule 13D is unchanged.

Item 1. Security and Issuer

Item 1 of the Schedule 13D is hereby amended and supplemented to add the following information:

As of January 30, 2017, the Reporting Persons beneficially own an aggregate of 99,312,825 shares of Common Stock (the <u>Subject Shares</u>), which number includes: (i) 25,492,225 shares of Common Stock, and (ii) 73,820,600 shares of Common Stock underlying American-style call options.

The Subject Shares represent approximately 6.4% of the issued and outstanding shares of Common Stock of the Issuer.

Since the date on which Amendment No. 2 was filed, the Subject Shares represent an increase of: (1) 2,550,000 shares of Common Stock and (ii) 8,565,600 shares of Common Stock underlying American-style call options.

Item 3. Source and Amount of Funds or Other Consideration

Item 3 of the Schedule 13D is hereby amended and supplemented to add the following information:

The source of funding for the transactions reported herein was derived from the respective capital of the Pershing Square Funds.

Item 5. Interest in Securities of the Issuer

Item 5(c) of the Schedule 13D is hereby amended and supplemented by adding the following information:

(c) Exhibit 99.8, which is incorporated by reference into this Item 5(c) as if restated in full, describes all of the transactions in the Common Stock or derivatives relating to Common Stock that were effected in the past 60 days by the Reporting Persons for the benefit of the Pershing Square Funds. Except as set forth in Exhibit 99.8 attached hereto, no reportable transactions were effected by any Reporting Person within the last 60 days.

Item 6. Contracts, Arrangements, Understandings or Relationships With Respect to Securities of the Issuer. On January 27, 2017, the Reporting Persons on behalf of the Pershing Square Funds extended the maturity of certain over-the-counter option contracts as further detailed in Exhibit 99.8. None of the options gives the Reporting Persons direct or indirect voting, investment or dispositive control over any securities of the Issuer or requires the counterparty thereto to acquire, hold, vote or dispose of any securities of the Issuer.

The form of option contract has previously been filed as Exhibit 99.4. Supplemental financial terms of these contracts are detailed in Exhibit 99.8 for transactions in the last 60 days.
