- Shares disposed of at the closing of the Agreement and Plan of Merger, dated as of October 22, 2009, by and among Western Sizzlin Corporation (the "Issuer"), The Steak n Shake Company ("Steak n Shake") and Grill Acquisition Corporation, a wholly-owned subsidiary (1) of Steak n Shake, pursuant to which each outstanding share of the Issuer's common stock was canceled and converted into the right to receive a pro rata portion of a new issue of 14% redeemable subordinated debentures due 2015 issued by Steak n Shake in the aggregate principal amount of \$22,959,000 (the "Debentures"), with cash paid in lieu of fractional Debenture interests.
