- (4) I also receive phantom stock units as a result of my participation in an excess benefit plan. This total includes 4,747.8171 units in such plan in addition to units held through my account balance in a deferred compensation plan. I also receive dividends.
- (5) I have been granted an option to purchase 100,000 shares at a price of \$77.14 such shares vest on or about February 1, 2010. The expiration date of these options is October 24, 2012.
