On November 17, 2003, the reporting person was granted 120,000 employee stock options, which would vest in installments based on the Company's satisfaction of certain performance-related criteria. On February 27, 2006, the Company's compensation committee approved (1) the Company's satisfaction of performance-related criteria for the year ended December 31, 2005, which resulted in the vesting of 72,000 employee stock options. The remaining 48,000 options became exercisable on March 29, 2005 upon the determination that the performance criteria had been satisfied, and were reported at that time.
