- Although Mr. Georgius has not received any derivative security that would require the filing of a Form 4, On March 31, 2008, Mr. Georgius was granted 3,135 long term incentive plan units ("LTIP units") pursuant to Cogdell Spencer Inc.'s (the "Company") 2005 long-term stock incentive plan. The LTIP units may be convertible into limited partnership units ("OP units") in Cogdell Spencer LP (the "Operating Partnership"), if there is an increase in the value of the Operating Partnership's assets, which revaluation will occur upon the occurrence of certain events (each a "Book-up Event"). OP units are redeemable for a cash amount equal to the value of OP units or, in the Company's sole and absolute discretion, exchangeable for shares of the Company's common stock based on an exchange ratio of one share of common stock for one OP unit.
- (1) "Operating Partnership"), if there is an increase in the value of the Operating Partnership's assets, which revaluation will occur upon the occurrence of certain events (each a "Book-up Event"). OP units are redeemable for a cash amount equal to the value of OP units or, in the Company's sole and absolute discretion, exchangeable for shares of the Company's common stock based on an exchange ratio of one share of common stock for one OP unit.
 - (2) The 3,135 LTIP units granted to Mr. Georgius vested on March 31, 2008. Upon a Book-up Event, some or all of the 3,135 LTIP units granted to Mr. Georgius may be converted into OP units, thereby increasing the number of OP units owned by Mr. Georgius by the corresponding number of LTIP units converted into OP units. At this time, there has been no transaction involving Mr. Georgius that would require the filing of a Form 4 and this Form 4 is being filed for informational purposes only.
 - (3) Although not a derivative security, Mr. Georgius owns an aggregate of 3,135 LTIP units.
