- (1) Each restricted stock unit represents a contingent right to receive one share of GB common stock. The restricted stock units vest in four installments; 50% on the last day of the fiscal year 2010, 25% on the last day of fiscal year 2011, (2) and 25% on the last day of fiscal year 2012. Vested shares will be delivered to the reporting person on the first business day following the vest date unless the reporting person terminates employment with GB prior to that time.
- (3) Grant of non-qualified stock options that vest in four equal annual installments on the last day of each fiscal year, beginning 2009.
