(1) On January 9, 2009, one-third of the shares of restricted stock granted to Mr. Gatto on January 9, 2007 vested. In addition, 1,938 shares of Idearc common stock were received upon settlement of dividend equivalent RSUs related to these shares of restricted stock. The 5,505 shares reported on this Form 4 were withheld to satisfy tax withholding obligations related to the foregoing.

(2) Includes 1,937 dividend equivalent RSUs accrued on shares of restricted stock held by Mr. Gatto. The dividend equivalent RSUs accrued when and as dividends were paid on Idearc common stock and are subject to the same vesting provisions of the shares of restricted stock to which they relate.
