(1) These securities are restricted stock units. Each unit represents the Reporting Person's right to receive one share of Common Stock, subject to the applicable vesting schedule.

(2) These restricted stock units shall vest at the rate of 1/4th of the shares subject to such restricted stock units as of the first anniversary of the Vesting Commencement Date and 1/4th of the shares subject to such restricted stock units as of each of the subsequent anniversaries of the Vesting Commencement Date thereafter, assuming continued service with the Company on each vesting date. For the purposes of the restricted stock unit grants, the Vesting Commencement Date is 2/1/2010.

(3) These common stock shares were withheld from the common stock shares which vested from RSUs granted on February 1, 2009. Such shares were withheld by the Company as required for related tax liability.

(4) Options granted are to be exercisable at the rate of 1/48th of the shares subject to such options at the end of each month following the vesting commencement date. Such options have a term of seven years from the date of grant.
