The shares of common stock, including restricted stock, were cancelled pursuant to the Agreement and Plan of Merger with Buccaneer Holdings, Inc. and Buccaneer Merger Sub, Inc., dated as of October 28, 2010 (the "Merger Agreement"), in exchange for a cash payment in the amount of \$31.00 per share.

- (1) The shares of common stock, including restricted stock, were cancelled pursuant to the Agreement and Plan of Merger with Buccaneer Holdings, Inc. and Buccaneer Merger Sub, Inc., dated as of October 28, 2010 (the "Merger Agreement"), in exchange for a cash payment in the amount of \$31.00 per share.
- (2) The options, whether vested or unvested, were cancelled pursuant to the Merger Agreement in exchange for a cash payment in the amount of \$31.00 per share less the exercise price of the option.
- (3) The option vests in three equal installments on each of June 2, 2009, June 2, 2010 and June 2, 2011.
- (4) The option vests in three equal annual installments on each of June 2, 2010, June 2, 2011 and June 2, 2012.
- (5) The option vests in three equal annual installments on each of August 10, 2010, August 10, 2011 and August 10, 2012.
- (6) The option vests in three equal annual installments on each of February 17, 2011, February 17, 2012 and February 17, 2013.
- (7) The option vests in three equal installments on each of August 5, 2011, August 5, 2012 and August 5, 2013.
