- (1) Shares acquired upon the vesting of a portion of the performance shares granted in 2010.

- (4) The reporting person gifted the shares received on February 19, 2013 to a revocable family trust.

Each Restricted Stock Unit represents a contingent right to receive the economic equivalent of one share of the Company's common stock. The Restricted Stock Units will be settled, at the reporting person's election, in shares of common stock or 50% in common stock and 50% in cash.

- (6) The Restricted Stock Units vest and will be settled in four equal, annual installments beginning on February 20, 2014.
