- (1) Pursuant to the Endo Health Solutions Directors Stock Election Plan, on December 5, 2012, Dr. Nash elected to receive 100% of his 2013 cash retainer fees in Endo common stock. At the time that the retainer fees would otherwise have been payable, the number of shares of Endo common stock are fixed and are reported as of such date on Table I as an acquisition of securities. These cash retainer fees are payable to Dr. Nash in consideration of his services on the Endo Health Solutions Inc. Board of Directors for the second quarter 2013. Under the Endo Health Solutions Inc. Deferred Compensation Plan, also on December 5, 2012, Dr. Nash elected to defer receipt of all of these shares.
- (2) This number represents (i) 11,307 shares of common stock, 10,637 of which have been deferred under the Endo Health Solutions Directors Deferred Compensation Plan and (ii) 6,515 restricted stock units.
