- (1) One-third (16,667) of the Equity Participation Units (the "Phantom Units") held by the Reporting Person vested on May 13, 2015, and the remaining two-thirds of the Phantom Units vest on the later to occur of the date that the Pony Express Crude Oil Pipeline is initially placed into commercial service by Tallgrass Pony Express Pipeline, LLC or May 13, 2017.
