- (3) Each restricted stock unit represents a contingent right to receive one share of ViaSat, Inc. common stock.
Subject to the reporting person's election to defer the receipt of common stock, the units vest and convert into shares of common stock of
- (4) the Issuer at a rate of 1/4 on the 13th month anniversary of the grant date; 1/4th on the second anniversary of the grant date; 1/4th on the third anniversary of the grant date and 1/4 on the fourth anniversary of the grant date.
- (5) Until vested, the restricted stock unit shall be subject to forfeiture in the event of termination of employment or service with the issuer.
The original restricted stock unit grant was for 3,500 restricted stock units on 11/17/2014. Subject to the reporting persons's continued
- (6) employment with the Issuer, the units vest and convert into shares of common stock (on a 1-for-1 basis) in four (4) equal annual installments beginning on 11/17/2015.
