(1) The 7,619 shares of common stock were granted as restricted stock pursuant to the Company's Amended and Restated 2003 Stock Incentive Plan on March 5, 2018. Restrictions lapse in 16 quarterly installment with the first 15 installments of 476 shares each beginning on April 1, 2018 and thereafter with 476 shares on April 1, July 1, October 1 and January 1 of each year with the final 479 shares lapsing on January 1, 2022.
