 - (4) The 25,226 shares reported are owned directly by the Trust u/l/w Janice P. Mosing f/b/o Victoria R. Mosing, of which William B. Mosing is the trustee. Mr. Mosing disclaims beneficial ownership of the Common Stock owned by the trust, except to the extent of his pecuniary interest therein.
 - (5) The 25,226 shares reported are owned directly by the Trust u/l/w Janice P. Mosing f/b/o Jaclyn E. Mosing, of which William B. Mosing is the trustee. Mr. Mosing disclaims beneficial ownership of the Common Stock owned by the trust, except to the extent of his pecuniary interest therein.
 - (6) The 39,145 shares reported are owned directly by the By-Pass Corporate Stock Trust u/l/w Janice P. Mosing f/b/o William B. Mosing, of which William B. Mosing is the trustee.
