Performance Units convert 1 for 1 into shares of Company common stock. There is no purchase or sales price upon vesting of the Performance Units. Includes accrued dividends. Share amounts reflect an increase due to the 3-for-2 stock split as of 3/3/08.
  - (2) Includes actual number of shares that vested, including shares held outright, shares held in New Jersey Resources Compensation Deferral Plan and shares held in Dividend Reinvestment Plan.
  - (3) Represents shares of common stock withheld by the Company to satisfy tax withholding obligation.
