## GOL Announces Traffic Statistics for July 2005

**São Paulo, August 3, 2005** GOL Linhas Aéreas Inteligentes S.A. (NYSE: GOL and Bovespa: GOLL4), Brazil's low-fare, low-cost airline, today released preliminary passenger statistics for the month of July 2005. System-wide passenger traffic for July increased 62.1%, while capacity increased 55.5%. As a result, GOL's system load factor reached 80.0%.

Domestic passenger traffic (RPK) for July increased 53.6% while capacity (ASK) increased 47.9%. Accordingly, domestic load factor for the month increased 3.0 points to 79.7%. These results mainly reflect improvements in demand, GOL market share gains, and the launch of new frequencies.

International passenger traffic for July increased to 50.1 mm RPK while capacity increased to 58.6 mm ASK. International load factor for the month was 85.5%.
