The Annual Meeting of Stockholders of AMETEK, Inc. (the Company) was held on May 1, 2012. The following matters were voted on at the Annual Meeting and received the number of votes indicated:

- 1) Election of Directors. The following nominees were elected to the Board of Directors for a term expiring in 2015:

Of the remaining four Board members, Charles D. Klein and Steven W. Kohlhausen terms expire in 2013 and Anthony J. Conti and Frank S. Hermance expire in 2014.

- 2) Advisory Approval of the Company's Executive Compensation. The Stockholders approved, on an advisory (non-binding) basis, the compensation of certain executive officers. The result of the vote was as follows:
