On October 12, 2017, the shareholder of ITC Holdings Corp. (the "Company") approved the recommendation of the Board of Directors (the "Board") to expand the size of the Board from ten to eleven directors and appointed A. Douglas Rothwell as a director of the Company. His appointment will be effective on October 20, 2017.
