(1) On June 30, 2009, a prior Form 4 was mistakenly re-filed by the issuer's filing agent on behalf of the reporting person, which reported a series of stock purchases by the reporting person totaling 3,000 shares of common stock. The June 30, 2009 Form 4 should have included only the grant of Deferred Stock Units ("DSUs") on June 27, 2009.

Each DSU represents the right to receive one (1) share of Tasty Baking Company common stock. The DSUs will vest on the completion by the reporting person of five (5) years of continuous service as a director. The reporting person has served as a director since May 2005.
