Rio de Janeiro, February 22, 2017 - Petroleo Brasileiro S.A. - Petrobras, in compliance with CVM Instruction 561/2015, which established the distance voting (Boletim de Voto a Distância) to be used at Ordinary General Meetings and Extraordinary General Meetings, in which there are election of members of the Boards of Directors and Fiscal Council, informs that has provided the instructions to use the referred voting in its Formulário de Referência.

The information is updated in item 12.2 of the Form, in the sub-items below:

g. formalities required for acceptance of distance voting sent directly to the company, indicating whether the issuer requires or waives signature certification, notarization, and consulate validation.

h. if the company provides an electronic system to receive distance voting or remote participation.
