At the meeting the following proposals were approved and adopted: (1) the election of six (6) Directors of the Company; (2) the appointment of Ernst & Young as the Company s independent auditors for the fiscal year ending December 31, 2009; and (3) an amendment to the Company s Articles of Incorporation to increase the number of authorized shares of the Company s Class A common stock, each as described in the AGM s Proxy Statement submitted to EDGAR in a Report on Form 6-K on August 31, 2009.

Excel Class A common shares have been listed since September 15, 2005 on the New York Stock Exchange (NYSE) under the symbol EXM and, prior to that date, were listed on the American Stock Exchange (AMEX) since 1998.
