(a) Amount Beneficially Owned:

As of the date of this filing, Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), is the beneficial owner of 410,176 shares of the Company's Common Stock, of which 1,000 shares are a constituent part of the Issuer's units. Each unit consists of one share of Common Stock and one warrant. Each warrant entitles the holder to purchase one share of the Company's Common Stock at a price of \$6.00 ("Warrants"). Each Warrant will become exercisable upon the Company's completion of a business combination. However, no Warrants will be exercisable unless the Company has an effective registration statement under the Securities Act covering the shares of Common Stock issuable upon exercise of the Warrants and a current prospectus relating to them is available. The Warrants will expire on November 19, 2011, or earlier upon redemption. As of the date of this filing, the Company has not announced the completion of a business combination and therefore, the Warrants are currently not exercisable. In addition to the 1,000 Warrants held as a constituent part of the Issuer's units, Integrated Core Strategies holds an additional 524,995 Warrants, which are also currently not exercisable.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. Israel A. Englander ("Mr. Englander"), is the managing member of Millennium Management. Consequently, Mr. Englander may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. The foregoing should not be construed in and of itself as an admission by Millennium Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies.
