(a) Amount Beneficially Owned:

As of the date of this filing, Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), is the beneficial owner of 2,058,835 shares of the Issuer's Common Stock. Integrated Core Strategies also holds 5,202,425 warrants. Each warrant entitles the holder to purchase one share of the Issuer's Common Stock at a price of \$7.00 ("Warrant"). Each Warrant will become exercisable upon the Issuer's completion of a business combination. However, no Warrants will be exercisable and the Issuer will not be obligated to issue shares of Common Stock unless at the time a holder seeks to exercise such Warrant, a prospectus relating to the Common Stock issuable upon exercise of the Warrants is current and the Common Stock has been registered or qualified or deemed to be exempt under the securities laws of the state of residence of the holder of the Warrants. The Warrants will expire on June 25, 2013, or earlier upon redemption. As of the date of this filing, the Issuer has not announced the completion of a business combination and therefore, the Warrants are not currently exercisable.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies, and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. Israel A. Englander ("Mr. Englander"), is the managing member of Millennium Management. Consequently, Mr. Englander may also be deemed to have shared voting control and investment discretion over securities beneficially owned by Integrated Core Strategies. The foregoing should not be construed in and of itself as an admission by Millennium Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies.

6.5% of the Issuer's Common Stock (see Item 4(a) above), which percentage was calculated based on 31,625,000 shares of Common Stock outstanding as of October 28, 2009, as per the Issuer's proxy statement dated October 30, 2009.
