- (3) Shares withheld to cover required tax withholding on vesting of restricted stock effective as of 06/01/2013 - data provided by plan administrator on 06/03/2013.

- (4) These shares are held in trust for the benefit of the reporting person's children. The reporting person and spouse are trustees.

- (5) With tandem tax withholding right

- (6) One share of Apache common stock for each restricted stock unit.
