On April 22, 2008, the Reporting Persons submitted an offer (the <u>Offer Letter</u>) to the Issuer s Board of Directors to acquire all of the outstanding shares of Common Stock for \$12.10 per share in cash (the <u>Proposed Transaction</u>). The offer is irrevocable and will remain open until 12:00 p.m. (EDT), on April 26, 2008, after which time it will expire if not accepted by the Issuer. The Offer Letter is attached hereto as <u>Exhibit 7</u> and incorporated by reference herein. No binding obligation on the part of the Reporting Persons will arise with respect to the Proposed Transaction unless and until a definitive acquisition agreement with the Issuer has been executed and delivered.
