Item 8.01. Other Events.

On March 2, 2017, Finjan, Inc. ("Finjan"), a wholly-owned subsidiary of Finjan Holdings, Inc. (the "Company"), entered into a Confidential Patent License Agreement (the "License Agreement") with Veracode, Inc., a Delaware corporation ("Veracode"). Pursuant to the License Agreement, Veracode will obtain a license to the Finjan patent portfolio and pay a license fee of \$2.0 million in cash, which Finjan received on March 2, 2017. Such license does not grant Veracode any right to transfer, sublicense or grant any rights under the License Agreement to a third party except as specifically provided under the License Agreement. Such license also has certain provisions relating to certain unlicensed products of any company that acquires Veracode, or is acquired by Veracode or its affiliates, in which case additional license fees may apply. The specific terms of the License Agreement are confidential.

A copy of the press release issued by the Company relating to the matters discussed above is attached hereto as Exhibit 99.1 and is incorporated herein by reference. The information in the press release shall not be deemed "filed" for purposes of Section 18 of the Securities Exchange Act of 1934, as amended (the "Exchange Act") or otherwise subject to the liabilities of that section, unless the Company specifically states that the information is to be considered "filed" under the Exchange Act or incorporates it by reference into a filing under the Securities Act of 1933, as amended, or the Exchange Act.
