Description of Terms

- Linked to the S&P 500® Index

Unlike ordinary debt securities, the securities do not pay interest, do not repay a fixed amount of principal at maturity and are subject to potential automatic call upon the terms described below. Any return you receive on the securities and whether they are automatically called will depend on the performance of the Index

Automatic Call. If the closing level of the Index on any call date is greater than or equal to the starting level, the securities will be automatically called, and on the related call settlement date, you will receive the original offering price plus the call premium applicable to that call date

Maturity Payment Amount. If the securities are not automatically called prior to the final calculation day, the maturity payment amount will be based upon the closing level of the Index on the final calculation day and could be greater than, equal to or less than the original offering price per security as follows:

- o **If the level of the Index increases or remains flat:**

The securities will be automatically called for the original offering price plus the call premium applicable to the final calculation day described above

- o **If the level of the Index decreases but the decrease is not more than 10%:**

You will receive the original offering price of your securities at maturity

- o **If the level of the Index decreases by more than 10%:**

You will receive less than the original offering price and have 1-to-1 downside exposure to the decrease in the level of the Index in excess of 10%

- Investors may lose up to 90% of the original offering price
- Any positive return on the securities will be limited to the applicable call premium

Hypothetical Payout Profile

The profile to the right illustrates the potential payment on the securities for a range of hypothetical percentage changes in the closing level of the Index from the pricing date to the applicable call date (including the final calculation day). The profile is based on a call premium of 6.05% for the first call date, 12.10% for the second call date, 18.15% for the third call date and 24.20% for the final call date and a threshold level equal to 90% of the starting level.

This profile has been prepared for purposes of illustration only. Your actual return will depend on (i) whether the securities are automatically called; (ii) if the securities are automatically called, the actual call date on which the securities are called; (iii) if the securities are not automatically called, the actual ending level of the Index; and (iv) whether you hold your securities to maturity or earlier automatic call.

The last call date is the final calculation day, and payment upon an automatic call on the final calculation day, if applicable, will be made on the stated maturity date.

Any positive return on the securities will be limited to the applicable call premium, even if the closing level of the Index significantly exceeds the starting level on the applicable call date. You will not participate in any appreciation of the Index beyond the applicable call premium.

How The Maturity Payment Amount Is Calculated

If the securities are not automatically called prior to the final calculation day, then on the stated maturity date you will receive a cash payment per security equal to the maturity payment amount. The maturity payment amount per security will equal:

If the ending level is greater than or equal to the starting level: \$1,000 *plus* the call premium applicable to the final calculation day as described above under “Call Dates and Call Premiums”;

- If the ending level is less than the starting level but greater than or equal to the threshold level: \$1,000; or
 - If the ending level is less than the threshold level: \$1,000 *minus*

If the securities are not automatically called prior to the final calculation day and the ending level is less than the threshold level, you will receive less, and possibly 90% less, than the original offering price of your securities at maturity.
