The Reporting Person sold 1.874% of the shares outstanding based on 19,268,423 shares outstanding as reported on the Issuer's Notice of Joint Annual Meeting of Shareholders to be held on August 22, 2017. Reporting Person's intent going forward is investment only.

The Reporting Person has sole voting and dispositive power with respect to all shares of the Issuer's common stock beneficially owned by Reporting Person.
