**Entry into a Material Definitive Agreement.**

On June 1, 2011, ARMOUR Residential REIT, Inc. (the Company) entered into an underwriting agreement (the Underwriting Agreement) with Deutsche Bank Securities Inc. acting for itself and as a representative of the several underwriters named therein (the Underwriters), related to its follow-on public offering (the Offering) of 16,000,000 shares of the Company's common stock, par value \$0.001 per share (the Securities), excluding an Underwriters' option (the Option) to purchase an additional 2,400,000 shares during the 30-day period following the Offering.

The Underwriters agreed to purchase the shares from the Company pursuant to the Underwriting Agreement at a price to the public of \$7.40 per share, exclusive of Underwriters' discounts and commissions. The shares were offered and sold under a prospectus supplement and accompanying prospectus filed with the Securities and Exchange Commission pursuant to the Company's shelf registration statement on Form S-3 (File No. 333-173682). The Offering is expected to close on June 6, 2011. The foregoing description of the Underwriting Agreement is qualified in its entirety by reference to the Underwriting Agreement attached hereto as Exhibit 1.1 and incorporated by reference herein.

The material terms of the Securities are described in the Company's prospectus supplement, as filed with the Commission on June 2 (after 5:30), 2011 pursuant to Rule 424(b)(5) of the Securities Act, which relates to the offer and sale of the Securities and supplements the Company's prospectus contained in the Registration Statement, as filed with the Commission on May 4, 2011.
